NOTICE---READ BEFORE SIGNING

Rules that I agree to, acknowledge and confirm.

1. Do not leave any trash in the fields.
2. Stay a safe distance from other hunters.
3. Wear proper eye protection.
4. Be aware of all Texas game laws
5. Bird cleaning in field or designated areas at camp. Do not clean inside cabins or leave carcasses in trash cans at camp.
6. Every effort will be made to retrieve and recover every bird shot.
7. A wounded bird will count towards your limit.
8. While hunting you must stay in your designated area described by your guide.
9. You will be personally responsible to any and all bodily injury or property damage caused by you.
10. You will be responsible for any minor child to abide by these agreements that may be with you during the hunt.
11. All hunter/guests must read and sign the hold harmless agreement below:

The undersigned acknowledges that hunting can be a hazardous and dangerous sport and are familiar with all of the risks and hazards involved and assumes for themselves, all such risks and hazards. Mark Katzfey, DBA Katzfey Ranches and its Lessors and or property owners, will not be liable for any loss, damage or injury of any kind or character to the undersigned guest or to their property arising from any use of the hunting premises or other casualty thereon, or occasioned by the failure of the undersigned to conduct their activities on the premises in a safe and reasonable manner, or arising from any cause whatsoever, and undersigned hereby waives on their behalf all claims and demands against Mark Katzfey/Katzfey Ranches for any such loss, damage or injury and agrees to indemnify and hold Mark Katzfey/Katzfey Ranches and its Lessors entirely free and harmless from all liability for any such loss, damage or injury of other persons and from all costs and expenses arising therefrom.
